- 1.The Company has 61 outstanding FCCBs held by one bond holder. 81,314 equity shares will be issued against these FCCBs in case the bond holder exercises the conversion right.
2. The Company has allotted 5,03,24,324 warrants on preferential basis which are convertible into equal number of equity shares of Re. 1/- each face value.
3. Pursuant to SEBI Buy back Regulations and Public Announcement dated July 11, 2022 and the buyback of equity shares undertaken by the Company, 33,23,251 equity shares has been extinguished during the quarter ended December 31, 2022. Accordingly, the Issued and Paid-up equity share capital of the Company has come down to 40,30,34,114 equity shares as on December 31, 2022.
